Lodging an objection

You can use this form to lodge an objection against a decision of the CAK relating to:

- the defaulters scheme;
- the uninsured persons scheme;
- the health insurance outside the Netherlands scheme;
- the conscientious objectors scheme;
- the uninsurable aliens scheme.

You must enclose the following documents with your objection letter:

- A copy of the decision to which you are objecting.
- Copies of any supporting documents to substantiate your objection.
- The authorisation form if someone else is lodging the objection on your behalf.
